- **Operadora:** indisponibilidade causada por falha nos enlaces de operadora atendendo o PoP.
- **Infraestrutura PoP:** indisponibilidade causada por falha no fornecimento de energia elétrica do PoP.
- **Prog-PoP:** indisponibilidade causada por manutenção programada solicitada pelo PoP.
- **Prog-operadora:** indisponibilidade causada por manutenção programada solicitada por operadora.
- **Prog-daero:** indisponibilidade causada por manutenção programada solicitada pela DAERO/RNP.
- **PoP-concentrador:** indisponibilidade em um PoP que é decorrente da queda de um outro PoP concentrador.
- **Staff-daero:** indisponibilidade decorrente de ação direta da DAERO, incluindo erros de configuração roteadores e switches, interrupções de circuitos causadas por chamados abertos indevidamente, entre outros.
- **Staff-PoP:** indisponibilidade decorrente de ação direta do PoP, incluindo desligamentos acidentais, manuseio inadequado de cabos, problema de acesso físico ao PoP (para manutenção de operadoras),entre outros.
- **Roteador:** indisponibilidade causada por falhas de hardware/software de roteadores.
